

Tyne & Wear Concessionary Travel Scheme Gateshead Council Eligibility Application

If you are disabled and live in Tyne & Wear you may be eligible for a concessionary travel pass. If you are assessed as eligible for the concessionary travel scheme you will be issued with a confirmation of eligibility form, which allows you to apply for the concessionary travel pass from NEXUS.

The Concessionary Travel Pass allows you to travel:

- Free of charge on buses in Tyne & Wear from 9:30am Monday to Friday and all day at weekends and on public holidays
- Free anywhere else in England on local buses, between 9:30am and 11:00pm Monday to Friday and all day at weekends and on public holidays
- For 60p* on the Shields Ferry from 9:30am Monday to Friday, all day at weekends and on public holidays
- For 50p* on Northern Rail services between Newcastle and Metro Centre/Blaydon, from 9:30am Monday to Friday and all day at weekends and on public holidays

Please complete all relevant sections of the application form. You must provide acceptable proof of your disability, failure to do this will result in your application being rejected.

Disability Living Allowance or Personal Independence Payment information must be an original copy and dated within the last 6 months, you can obtain replacement certificates from the Disability Benefits Agency at the Department of Work and Pensions.

Please note – Gateshead Council are not responsible for any costs incurred in respect of GP letters or proof provided by GP's on behalf of the applicant. Any costs must be met by the applicant.

The personal information that you provide on this form will be kept by the Council who are partners in the Tyne and Wear Concessionary Travel Scheme. This information will be handled in line with GPDR and will be used for the purpose of assessing your eligibility for the Concessionary Travel Scheme and to manage, monitor and evaluate the service only. Information about you will not be used for any other purpose.
